ARTICLES OF INCORPORATION

OF

INTERNATIONAL MTM DIRECTORATE, INC.

The undersigned, a majority of whom are citizens of the United States, desiring to form a non-profit corporation under Chapter 1702 of the Revised Code of Ohio, do hereby certify:

FIRST: The name of the corporation shall be INTERNATIONAL MTM DIRECTORATE, INC.

SECOND: The place in the State of Ohio where the principal office of the corporation is to be located is the City of Columbus, Franklin County.

THIRD: The purposes for which this corporation is formed are:

- (1) To develop, maintain, and enforce high standards of Methods Time Measurement (MTM) practice and rigorous membership requirements.
- (2) To encourage and coordinate at the international level the research activities of the National MTM Associations.
- (3) To maintain uniformity in MTM application practice, including establishment of minimum requirements for training in MTM and examination procedures, and

specification of the use of the official standards and symbols.

- (4) To spread the sound usage of MTM by suitably publicizing the value of the procedure, by giving encouragement to the formation of national MTM associations and by rendering assistance to them as needed.
- (5) To encourage the widespread usage of MTM by assuring that in each country, several sources by official qualifications, are admitted to do MTM training and application work.
- (6) To encourage close cooperation among all those interested in MTM research, training and application, including universities, MTM practitioners, and those from related professional disciplines.

FOURTH: No part of the net earnings of the corporation shall enure to the benefit of or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Third.

SIXTH: A Code of Regulations may be adopted for the government of the corporation containing provisions for the conduct of its affairs, the manner and method of establishing its membership and Trustees, the management of its property, and other provisions not inconsistent with law and the Articles of Incorporation.

SEVENTH: Any action which may be authorized or taken at a meeting of the members or of the Trustees of the corporation, as the case may be, may be authorized or taken without a meeting with the affirmative vote or approval of, and in a writing or writings signed by all of the members or all of the Trustees, as the case may be, who would be entitled to notice of a meeting for such purpose, or, in the case of members, such other proportion or number of voting members as the Articles or Regulations permit. Any such writing shall be filed with or entered upon the records of the corporation.

EIGHTH: Pursuant to Ohio Revised Code Section 1702.08, International MTM Directorate, Inc. shall succeed to and be vested with the rights, privileges, powers, authorities, properties, and obligations of International MTM Directorate (an unincorporated association), such unincorporated association having duly authorized incorporation by vote as provided by Ohio Revised Code Section 1702.08, and the members of such unincor-

porated association shall become members of this corporation upon the filing of these Articles of Incorporation.
